### RECOMMENDATION

1. That the ¾ Minus Gravel Tender be awarded to Peterson Construction of Estevan for \$18.00 per cubic yard to supply and deliver 2,500 cubic yards to the City of Estevan Maintenance Yard. The total of this purchase is \$45,000.00 before applicable taxes.

### **CONCLUSION**

This stockpile of 3/4 minus gravel is entered into the City Stores inventory and is charged out to various jobs in many Departments City wide.

### BACKGROUND AND DISCUSSION

The City of Estevan keeps ¾ minus gravel in stock for many reasons and applications. This particular product we use for graveling our gravel roads, backfill for water breaks, back lanes, and other projects. This product is necessary in day to day operations for the City of Estevan.

# CITY OF ESTEVAN POLICIES AND PROCEDURES MANUAL

POLICY # 2017-66

**SUBJECT: Community Grants and City Funding** 

### 1.0 PURPOSE

To fund and partner with community non-profit or charitable organizations to deliver programs, projects and services that align with the City's strategic priorities, have a clear community impact and respond to current and future community needs.

### 2.0 SCOPE

This policy applies to all non-profit organizations in Estevan who apply for City funding. The Community Grants Program funds organizations preset yearly budget constriants.

### 3.0 **DEFINITIONS**

Community Partner - Up to three years of core operation and core program funding to organizations that play a strategic and essential role in Estevan.

Financial Statement – an audited report completed by an external professional accounting organization on behalf of the client making a request to the City.

*Hosting* – funding for organizations up to \$100,000 for sanctioned amateur championship events at the provincial, Western Canadian, national or international level being held in Estevan. (ie: summer games, Western Canada Cup, Curling Briers, etc.)

Special Events – funding for organizations up to \$10,000 for one time and first time events that celebrate, preserve and enhance Estevan's identity by commemorating notable people, places and events, symbols and anniversaries or reoccurring local events that promote the values of citizenship and identity on nationally recognized days (including Canada Day, National Aboriginal Day, and Remembrance Day).

*Sponsorships* - Funding for organizations up to \$5,000 for new or unique one-time events that contribute to building community pride and encouraging community interaction and spirit.

#### 4.0 POLICY

### **Eligibility**:

Only registered non-profit or charitable organizations are eligible for community partner funding. Where organizations are offering the same or similar type programming, the City will only fund one organization that aligns with the City's strategic priorities. Organizations with similar mandates are encouraged to develop partnerships to maximize resources and available funding. All events or programs must take place in the City of Estevan to be eligible for funding.

Non-profit, Charitable and/or community based committees who have a clear organizational structure are eligible for special event, sponsorship, and hosting grants.

All other applicants will be considered on a case by case basis with a view to funding initiatives that have a clear community impact and need.

### **Applications**:

All applications for funding must be submitted to the City Clerk via e-mail at <a href="mailto:cityclerk@estevan.ca">cityclerk@estevan.ca</a> or City Clerk's Office at 1102 4<sup>th</sup> Street, Estevan, SK S4A 0W7.

All applicants may be required to provide the following information:

- Copy of most recent annual budget
- Copy of most recent audited financial statement
- Saskatchewan Non-Profit/Charitable # and Profile Report from ISC
- In the case of individuals or non-registered organizations, a copy of current board, committee and/or organizational structure
- Two letters of reference

### Fundraising Events:

The City only provides in kind support for local fundraising activities which includes use of City facilities, and staff assistance with set up and take down. The organization bears all other expenses and must have a Saskatchewan Lottery License to be eligible. Organizations applying for funding under one of the grants identified above may not receive both monetary funding and in kind support for the same event.

The City of Estevan must be appropriately recognized for their contribution as a funder. This includes the City's logo on printed communication, signage, radio/digital adds, etc., at a cost to the organization. Requirements for this recognition will be identified at the time of approval.

### 5.0 Evaluation Criteria

be submitted for all program categories however given the limited funding available, organizations will only be approved for one program.

### Culture:

- Improve awareness and access to cultural activity and resources; e.g., artistic practices, cultural spaces, cultural industries.
- Reflect the cultural aspirations of newcomers, First Nations, Métis and Inuit people.
- Strengthen the cultural community through meaningful partnerships between organizations.
- Encourages or brings the City's public spaces to life.

### **Social Development:**

- Supports the community in creating collaborative strategies to address hunger and food security as well as access to housing.
- Strengthen development of safe neighbourhoods through community activities and resources.
- Collaborate with organizations that represent newcomers, residents with disabilities,
   First Nations, Métis, Inuit people and citizens who are marginalized to build a welcoming and socially inclusive community.

### **Sport and Recreation:**

- Increase accessibility to sport and recreation activities and resources, including sporting events and celebrations.
- Support community initiatives that address the recreation aspirations of our diverse community.
- Promote active and healthy lifestyles among children and youth.
- Support community initiatives that encourage multi-season use of open space.

### 6.0 ROLES AND RESPONSIBILITIES

### **City Clerk**

Accepts and compiles applications for the Community Grants Review Committee.

### **City Council**

Approves the policy and community grant funding annually through the Budget process.

### City Manager

Approves/denies all requests for sponsorship funding under \$5,000.

### **City Treasurer**

Responsible for ensuring the recommended funding for organizations is included in the annual budget prior to Council consideration.

### **Community Grants Review Committee**

Administrative Committee comprising of the City Manager, City Controller, Mayor, and at. This committee will determine if funding is given based on request and funds available.


