BYLAW NO. 2005-1708

BEING A BYLAW OF THE CITY OF ESTEVAN IN THE PROVINCE OF SASKATCHEWAN TO REGULATE THE TEMPORARY CLOSING OF STREETS AND PROVINCIAL HIGHWAYS LYING WITHIN THE CITY OF ESTEVAN.

WHEREAS by virtue of the authority granted to the City of Estevan by Sections 12, 13, 14 and 15 of *The Cities Act*, including amendments thereto, the City may, by bylaw, control and regulate or prohibit vehicular or pedestrian traffic and control and regulate the use of all streets, sidewalks and other public places and may designate these powers to the Chief of Police or Public Works Manager.

AND WHEREAS the Council of the City of Estevan deems it necessary and desirable to establish by bylaw and to control and regulate and prohibit the use of streets, sidewalks and other public places during specific times.

NOW THEREFORE the Council of the City of Estevan hereby enacts as follows:

1. BYLAW TITLE

This Bylaw may be cited as the "Temporary Street Closing Bylaw".

2. **DEFINITIONS**

For the purpose of this Bylaw the following terms, phrases, words and their derivatives shall have the meanings given herein.

- a) "act" means *The Cities Act* and amendments thereto.
- b) "Chief of Police" shall mean the Chief of Police or his designate.
- c) "Public Works Manager" shall mean the Manager of the Public Works Services Business Division for the City of Estevan any anyone acting as such during the absence of the Public Works Manager from duty for any reason.
- d) "City Manager" means the person appointed by bylaw of the Council of the City of Estevan to the position of City Manager pursuant to Section 84 of the Act or his designate.
- e) "Department" means the Department of Highways and Transportation as is defined by *The Highways and Transportation Act*, 1997.
- f) "Minister" means the member of the Executive Council to whom for the time being, the administration of *The Highways and Transportation Act*, 1997 as amended from time to time is assigned;
- g) "Provincial Highway" means a public highway, or a proposed public highway in respect of which there is a plan in the Department designated by regulation as a provincial highway by

the Lieutenant Governor in Council, lying within the municipality.

- h) "Provincial Highway Continuity Street" means a street in respect of which there is a plan on file in the Department that provides to a provincial highway continuity lying within the urban municipality.
- i) "Street" means all or any part of a road allowance, public highway, road, lane, bridge, place, alley, square, thoroughfare or way intended for or used by the general public for the passage of vehicles or pedestrians and includes a provincial highway and a provincial highway continuity street.

STREET, SEWER OR WATER CONSTRUCTION, REPAIRS OR REPLACEMENT 3.

The Council of the City of Estevan hereby designates the Public Works Manager as the official to regulate or prohibit vehicular or pedestrian traffic on a street or any portion of a street for the purposes of carrying out street, sewer line or water line construction, repair or improvement or any other work authorized pursuant to this Act or any other act on the following terms and conditions:

- a) The regulation or prohibition under this Section shall not exceed 21 days;
- b) The regulation or prohibition shall be forthwith communicated to the following: Ambulance Services

Chief of Police Fire Chief City Manager

Radio Stations (if necessary)

- c) Every street or provincial highway or provincial highway continuity street that is closed pursuant to this Section is to be marked with a reasonable number of signs indicating the street's closure, and the hazards, if any, that would be encountered in its use during the closure;
- d) Specifics are to be provided concerning the erection of barricades and warning devices pertinent to locations to protect life and property;
- e) The authority to be granted to block, prohibit or regulate vehicular or pedestrian traffic for the purposes described in this Section shall be in a written form substantially the same as the Authorization attached hereto and marked as Schedule "A" to this bylaw and shall include the terms and conditions of this Section.
- f) The terms and conditions set by the Minister if the regulation or prohibition is in respect to a provincial highway or provincial highway continuity street;
- g) The applicant shall provide to the City of Estevan an Agreement to Indemnify as attached to this Bylaw;

CONSTRUCTION, REPAIR OR DEMOLITION OF A BUILDING OR STRUCTURE 4.

The Council of the City of Estevan hereby designates the Chief of Police as the official to regulate or prohibit vehicular or pedestrian traffic on a street or any portion of a street for the moving, construction, improvement, repair or demolition of a building or a structure on the following terms and conditions:

- a) The regulation or prohibition shall not exceed 21 days;
- b) The regulation or prohibition shall be forthwith communicated to the Chief of Police and City Manager;
- c) Every street or provincial highway or provincial highway continuity street that is closed pursuant to this Section is to be marked with a reasonable number of signs indicating the street's closure, and the hazards, if any, that would be encountered in its use during the closure;
- d) Specifics are to be provided concerning the erection of barricades and warning devices pertinent to locations to protect life and property;
- e) The authority to be granted to block, prohibit or regulate vehicular or pedestrian traffic for the purposes described in this Section shall be in a written form substantially the same as the Authorization attached hereto and marked as Schedule "A" to this bylaw and include the terms and conditions of this Section.
- f) The terms and conditions set by the Minister if the regulation or prohibition is in respect to a provincial highway or a provincial highway continuity street;
- g) The applicant shall provide to the City of Estevan an Agreement to Indemnify as attached to this Bylaw;

5. PARADES AND ASSEMBLIES OF PERSONS

The Council of the City of Estevan does hereby designate the Chief of Police as the official to regulate or prohibit vehicular or pedestrian traffic on a street or any portion of a street for the purpose of a parade or any assembly of persons on the following terms and conditions:

- a) The temporary closure shall not exceed 12 continuous hours in duration of which not more than 3 hours during the period of 9 a.m. to 6 p.m. on any day;
- b) The authority to be granted to block, prohibit or regulate vehicular or pedestrian traffic for an assembly or parade shall be in a written form substantially the same as the Authorization attached hereto and marked as Schedule "A" to this Bylaw and shall include the terms of this Section;
- c) Specifics are to be provided concerning the erection of barricades and warning devices pertinent to locations to protect life and property;
- d) The regulation or prohibition shall be forthwith communicated to the following:

Chief of Police

Ambulance Services

Radio Stations (if necessary)

City Manager

Fire Chief

e) The applicant shall obtain and provide proof of special event insurance with third party

liability for benefit of City of Estevan;

- f) Except where the authorization is for a neighbourhood block party, the applicant shall provide to the City of Estevan an Agreement to Indemnify in a form substantially the same as that attached hereto and marked as Schedule "A" to this Bylaw;
- g) The terms and conditions set by the Minister if the regulation or prohibition is in respect to a provincial highway or a provincial highway continuity street;
- h) Every street or provincial highway or provincial highway continuity street that is closed pursuant to this Section is to be marked with a reasonable number of signs indicating the street's closure, and the hazards, if any, that would be encountered in its use during the closure;

6. PROVINCIAL HIGHWAYS

Notwithstanding Sections 3, 4, and 5, of this Bylaw, the powers delegated to the Public Works Director and Chief of Police are subject to the approval of the Minister and to any terms and conditions that he may require in his approval insofar as the regulation or prohibition pertains to a provincial highway, or a provincial highway continuity street.

7. PERMISSION FOR PARADE OR ASSEMBLY OF PERSONS

Any person wishing to regulate or prohibit vehicular or pedestrian traffic for the purpose set out in Section 5 of this bylaw shall apply to the Chief of Police for written permission to hold such assembly or parade at least 96 hours prior to the commencement thereof and shall provide the Chief of Police with such information as he shall require.

8. PERMISSION FOR SECTIONS 3 & 4

Any person wishing to regulate or prohibit vehicular or pedestrian traffic for the purpose set out in Sections 3 or 4 of this bylaw shall apply to the Public Works Manager for written permission at least 24 hours prior to the commencement thereof and shall provide the Public Works Manager with such information as he shall require.

9. NON-COMPLIANCE OF TERMS PARADES AND ASSEMBLIES OF PERSONS

If the terms and conditions of the written authorization to regulate or prohibit vehicular or pedestrian traffic for the purposes set out in Section 5 of this bylaw are not complied with, the Chief of Police may immediately withdraw the written authorization and give notice for the dispersal of all persons associated with the assembly or parade.

10. NON-COMPLIANCE OF TERMS SECTIONS 3 AND 4

If the terms and conditions of the written authorization to regulate or prohibit vehicular or pedestrian traffic for the purposes set out in Sections 3 or 4 of this bylaw are not complied with, the Public Works Manager may immediately withdraw the written authorization and give notice to cease the street closure.

11. REPEAL OF FORMER BYLAW

Bylaw No. 96-1488 and all of its amendments are hereby repealed.

12. EFFECTIVE DATE OF BYLAW

This Bylaw shall come into force and take effect from the final passing thereof.
